AN ORDINANCE AMENDING ORDINANCE NO. 6345 RELATIVE TO THE APPROPRIATION OF P15,480.00 FOR THE ACQUISITION OF THE PROPERTY OF MR. AND MRS. HERMENEGILDO R. ABUEG, BY SUBSTITUTING THE NAMES OF MISSES CECILIA B. ABUEG AND TERESITA B. ABUEG FOR THOSE OF MR. AND MRS. HERMENEGILDO R. ABUEG AND BY CHANGING THE SOURCE OF FUND INDICATED THEREIN.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Ordinance No. 6345 is hereby amended to read as follows:

"AN ORDINANCE APPROPRIATING THE AMOUNT OF P15,480.00 (P15,360.00 FOR THE LAND AND P120.00 FOR THE REGISTRATION FEES AND DOCUMENTARY STAMPS) TO BE MADE AVAILABLE FOR THE PAYMENT OF THE PROPERTY OF MISSES CECILIA B. ABUEG AND TERESITA B. ABUEG, DESCRIBED AS LOT NO. 11-A, BLOCK NO. 1900 OF PLAN (IRC) PSD-35210, CONTAINING AN AREA OF ABOUT 12.8 SQUARE METERS WHICH NOW FORMS PART OF ILAYA STREET, SAN NICOLAS, AT THE PRICE OF P1,200.00 PER SQUARE METER AS RECOMMENDED BY THE APPRAISAL COMMITTEE.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P15,480.00, or so much thereof, as may be necessary, is hereby appropriated out of the expected additional income from approved revenue-raising measures to be made available for the payment of the property of Misses Cecilia B. Abueg and Teresita B. Abueg, described as Lot No. 11-A, Block No. 1900 of Plan (IRC) Psd-35210, containing an area of about 12.8 square meters, which now forms part of Ilaya Street, San Nicolas, at the price of P1,200.00 per square meter as recommended by the Appraisal Committee, broken down as follows:

1. For the land	P15,360.00
2. For the registration fees and documentary stamps ..	<u>120.00</u>
Total - - - -	<u><u>P15,480.00</u></u>
