

AN ORDINANCE APPROPRIATING THE AMOUNT OF P9,975.95 TO BE MADE AVAILABLE FOR THE PURCHASE OF OFFICE FURNITURE AND EQUIPMENT AND SHOP TOOLS FOR FLARIDEL ELEMENTARY SCHOOL.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P9,975.95, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the purchase of office furniture and equipment and shop tools for Flaridel Elementary School, itemized as follows:
