

AN ORDINANCE AUTHORIZING THE CONSTRUCTION, ESTABLISHMENT AND OPERATION OF A MUNICIPAL PARKING LOT AT THE AREA BOUNDED BY CONCEPCION, P. BURGOS, HOSPITAL, AND ARROCEROS STREETS; AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The construction, establishment, and operation of a municipal parking lot at the area bounded by Concepcion, P. Burgos, Hospital, and Arroceros streets, described in Section 2 hereof is hereby authorized.

SEC. 2. The municipal parking lot shall be established on a portion of the land bounded by Concepcion, P. Burgos, Hospital, and Arroceros streets, situated in the District of Ermita, City of Manila.

SEC. 3. The supervision and administration of this municipal parking lot shall devolve upon the Department of Engineering and Public Works who shall detail for this purpose an official to be designated as Parking Lot Supervisor and such minor employees and laborers as circumstances may require. The Parking Lot Supervisor shall look after the proper care of the parking area and regulate the use thereof insofar as priority on a "first come, first served" basis, police rules and collection of fees are concerned: PROVIDED, HOWEVER, that the collection of fees and the issuance of tickets as official receipts for parking fees shall be undertaken by the City Treasurer or his duly authorized representative.

SEC. 4. For every hour of parking at the municipal parking lot, or a fraction thereof, a fee of twenty-five centavos (P0.25) shall be charged for every four-wheel vehicle, fifteen centavos (P0.15) for every three-wheel vehicle and ten centavos (P0.10) for every two-wheel vehicle: PROVIDED, HOWEVER, that for eight (8) hours of continuous parking, a maximum fee of one peso and fifty centavos (P1.50) shall be charged for every four-wheel vehicle, one peso (P1.00) for every three-wheel vehicle and seventy centavos (P0.70) for every two-wheel vehicle: PROVIDED, FURTHER, that trucks, buses, trailers and other big vehicles shall not be allowed in the parking area.

SEC. 5. The sum of P200,000.00, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated, to be made available to cover the expenses of construction, establishment and operation of the municipal parking lot authorized in Section 1 hereof.

SEC. 6. This ordinance shall take effect upon its approval.
