

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 6521, RELATIVE TO THE SALE OF THE CITY-OWNED LOT LOCATED AT STA. MARIA, BALTAZAR AND AMARLANHAGUI STREETS, TONDO, TO THE ACTUAL AND BONA FIDE TENANTS, BY CORRECTING THE NAMES OF CERTAIN TENANTS LISTED THEREIN AND BY CONSOLIDATING ALL THE AREAS ALLOTTED TO MARINA HERRERA AND MARTINA HERRERA UNDER THE NAME OF THE LATTER.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Section 1 of Ordinance No. 6521 is hereby amended to read as follows:

"SECTION 1. The sale of the residential lots comprising Lot 90, Block 3008, owned by the City of Manila, located at Sta. Maria, Baltazar and Amarlanhagui streets, Tondo, as surveyed by the Office of the City Engineer, at a price to be determined by the City Appraisal Committee, to the following actual and bona fide tenants therein is hereby authorized, to wit:
