

AN ORDINANCE APPROPRIATING THE AMOUNT OF P808,160.00 TO BE MADE AVAILABLE FOR THE ACQUISITION BY THE CITY OF MANILA OF THIRTEEN (13) RESIDENTIAL LOTS OWNED BY THE AGUS DEVELOPMENT CORPORATION, LOCATED AT VERDAD AND A. DE LA FUENTE STREETS, SAMPALOC, TO BE RESOLD AT COST TO THE ACTUAL AND BONA FIDE TENANTS THEREOF, UNDER CERTAIN CONDITIONS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P808,160.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the acquisition by the City of Manila of the residential lots hereinafter enumerated, owned by the Agus Development Corporation, located at Verdad and A. de la Fuente streets, Sampaloc, to be resold at cost to the following actual and bona fide tenants thereof, subject to availability of funds, to wit:


