AN ORDINANCE APPROPRIATING THE AMOUNT OF P471,742.79 TO BE MADE AVAILABLE FOR THE PAYMENT OF THE RETIREMENT GRATUITIES, TERMINAL LEAVES AND COMPENSATION BENEFITS OF THE EMPLOYEES OF THE DEFUNCT LAND TRANSPORTATION DIVISION OF THE OFFICE OF THE CITY ENGINEER, WHO WERE RETIRED AUTOMATICALLY BY VIRTUE OF THE ABOLITION OF SAID DIVISION ON JUNE 30, 1969.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P471,742.79, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the payment of the retirement gratuities, terminal leaves and compensation benefits of the following employees of the defunct Land Transportation Division of the Office of the City Engineer, who were retired automatically by virtue of the abolition of said division on June 30, 1969, to wit:
