





AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱214,483.26 TO BE MADE AVAILABLE FOR THE PAYMENT OF THE RETIREMENT GRATUITIES AND COMPENSATION BENEFITS OF CERTAIN EMPLOYEES OF THE DIFFERENT DEPARTMENTS AND OFFICES OF THE CITY GOVERNMENT.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱174,530.55, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the payment of the retirement gratuities and compensation benefits of certain employees of the different departments and offices of the City Government and the balance of ₱39,952.71 is hereby appropriated out of the funds provided for under Republic Act No. 5447, as amended by Republic Act No. 6053, to be made available for the payment of aforesaid claims to the personnel of the Division of City Schools, listed hereunder, to wit:
