AN ORDINANCE APPROPRIATING THE AMOUNT OF P142,738.63 TO BE MADE AVAILABLE FOR THE PAYMENT OF THE RETIREMENT GRATUITIES AND COMPENSATION BENEFITS OF CERTAIN EMPLOYEES OF THE DIFFERENT DEPARTMENTS AND OFFICES OF THE CITY GOVERNMENT.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1.
