AN ORDINANCE AUTHORIZING THE CHANGE IN DESIGNATION WITH CORRESPONDING INCREASE IN SALARY OF CERTAIN POSITION-ITEMS IN THE MANILA POLICE DEPARTMENT UNDER THE CURRENTLY ENFORCED BUDGET ORDINANCE NO. 6651, AND APPROPRIATING FUNDS NEEDED THEREFOR EFFECTIVE AS OF JULY 1, 1971.

Be it ordained by the Municipal Board of the city of Manila, that:

SECTION 1. The change in designation with corresponding increase in salary of the following position-items in the Manila Police Department under the currently enforced budget Ordinance No. 6651, effective as of July 1, 1971, is hereby authorized as follows:

SEC. 2. The amount of ₱16,800.00, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available for the payment of the difference in salaries of the positions mentioned in Section One hereof, covering the period from July 1, 1971 to June 30, 1972.

SEC. This ordinance shall take effect as of July 1, 1971.
