

AN ORDINANCE AMENDING POSITION-ITEMS NO. 110, 282, 156, 301, 58, 56, 666, 123 AND 59-I IN THE APPROPRIATION OF THE DEPARTMENT OF ENGINEERING AND PUBLIC WORKS UNDER ORDINANCE NO. 6651, EFFECTIVE AS OF JULY 1, 1971; AND APPROPRIATING FUNDS NEEDED THEREFOR.
