

AN ORDINANCE AMENDING SECTIONS 1, 3 AND 8 OF ORDINANCE NO. 3000, AS AMENDED, REQUIRING PERMIT ON ALL BUSINESSES, TRADES OR OCCUPATIONS; PRESCRIBING FEES THEREFOR; AND FOR OTHER PURPOSES.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Sections 1, 3 and 8 of Ordinance No. 3000, as amended, are hereby further amended to read as follows:

*SECTION 1. Permit necessary. - It shall be unlawful for any person or entity to conduct or engage in any business, trade or occupation without first having obtained a permit therefor from the Mayor and the necessary license from the City Treasurer.

SEC. 3. Fees. - There shall be paid to the City Treasurer for every permit issued by the Mayor for a business, trade or occupation, except those upon which the City is not empowered to license or to tax, an annual fee in accordance with the following schedule:

- 1. Occupation or trade ₱10.00
- 2. Business:

<u>CLASS</u>	<u>CAPITAL</u>	<u>ANNUAL FEE</u>
<u>A</u>	<u>Less than ₱3,000</u>	<u>₱10.00</u>
<u>B</u>	<u>₱3,000 or over</u>	<u>25.00</u>
<u>C</u>	<u>₱10,000 or over</u>	<u>50.00</u>
<u>D</u>	<u>₱50,000 or over</u>	<u>100.00</u>
<u>E</u>	<u>₱100,000 or over</u>	<u>250.00</u>

PROVIDED, That permits issued after June 30 of each year shall be charged for at fifty per centum of the prescribed annual rates: PROVIDED, HOWEVER, That in case of change of ownership or location of business, it shall be the duty of the owner, agent or manager of such business to secure a new permit and pay the corresponding permit fee as in the case of a new business.

SEC. 8. Repeal. - All ordinances or parts of ordinances inconsistent with the provisions of this Ordinance, except those which impose a higher annual fee than those provided herein, are hereby repealed or modified accordingly."

SEC. 2. This Ordinance shall take effect upon its approval.
