That;

SECTION 1. The sum of ONE HUNDRED FIFTY ONE MILLION
FOUR HUNDRED FIFTY-TWO THOUSAND EIGHT HUNDRED NINETY-NINE
PESOS AND SIXTY CENTAVOS (P151,452,899.60) or so much thereof
as may be necessary, is hereby appropriated out of the unappro-
priated funds existing in the City Treasury to be made available
for the expenses of the following departments, bureaus and/or
offices of the Government of the City of Manila for the Fiscal
Year from July 1, 1972 to June 30, 1973, to wit:
