

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 6430, RELATIVE TO THE APPROPRIATION OF P195,732.00 FOR THE ACQUISITION OF THE PROPERTY OF MR. CONRADO FRANCISCO, KNOWN AS LOT NO. 2-A OF THE SUBDIVISION PLAN PSD-25917, BEING A PORTION OF LOT 2, BLOCK 3803 OF THE CADASTRAL SURVEY OF THE CITY OF MANILA, SITUATED IN THE DISTRICT OF TONDO, TO BE SUBDIVIDED AND RESOLD TO THE THIRTEEN (13) TENANTS THEREOF, BY INCLUDING THE NAME OF FORTUNATO SAN PEDRO AMONG THE AWARDEES LISTED THEREIN.

Be it ordained by the municipal board of the city of Manila, that:

SECTION 1. section 1 of ordinance no. 6430 is hereby amended to read as follows:

"SECTION 1. The amount of p195,732.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the city treasury to be made available for the acquisition of the property of Mr. conrado francisco known as lot no. 2-A of the subdivision plan PSD-25917, being a portion of lot 2, block 3803, of the cadastral survey of the city of Manila, situated in the district of tondo, containing an area of about 1,087.40 square meters, at a price to be agreed upon between the owner of the property and the tenants thereof but not to exceed p180.00 per square meter, to be subdivided and resold to the following tenants on said property in accordance with the provisions of ordinance no. 4709.
