

AN ORDINANCE APPROPRIATING THE AMOUNT OF P130,775.20 TO BE MADE AVAILABLE FOR THE PAYMENT OF THE SALARIES OF HON. AVELINO M. CONSTANTINO OF BRANCH XII OF THE CITY COURT OF MANILA AND ITS PERSONNEL (P94,193.20) FOR THE FISCAL YEAR 1972-1973, AND FOR THE PURCHASE OF OFFICE EQUIPMENT NEEDED THEREAT (P36,582.00).

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P130,775.20, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the payment of the salaries of Hon. Avelino M. Constantino of Branch XII of the City Court of Manila and its personnel for the fiscal year 1972-1973, and for the purchase of office equipment needed thereat, broken down as follows:
