

AN ORDINANCE APPROPRIATING THE AMOUNT OF P500,000.00 TO BE MADE AVAILABLE FOR THE ACQUISITION BY THE CITY OF A PARCEL OF LAND OWNED BY JOSE LEGARDA ESTATE, LOCATED AT CALLE MINDANAO AND PANAY STREET, SAMPALOC, CONTAINING AN AREA OF ABOUT 3,535 SQUARE METERS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 52519, TO BE RESOLD TO THE BONA FIDE TENANTS THEREIN ON INSTALLMENT BASIS FOR NOT MORE THAN 40 YEARS. 183 B

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P500,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the acquisition by the City of a parcel of land owned by Jose Legarda Estate, located at Calle Mindanao and Panay Street, Sampaloc, containing an area of about 3,535 square meters, covered by Transfer Certificate of Title No. 52519, to be resold to the following bona fide tenants therein on installment basis for not more than 40 years:
