

AN ORDINANCE AMENDING ITEM VII "OPERATION AND MAINTENANCE OF THE MEDICAL RESIDENCY TRAINING PROGRAM" OF THE APPROPRIATION OF THE OSPITAL NG MAYNILA UNDER ORDINANCE NO. 7227, BY PROVIDING FOR THE ITEMIZATION OF THE EXPENDITURES OF SAID ITEM.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Item VII "Operation and Maintenance of the Medical Residency Training Program" of the appropriation of the Ospital Ng Maynila under Ordinance No. 7227, is hereby amended to read as follows:
