

AN ORDINANCE AMENDING SECTION 314 OF THE COMPILATION OF ORDINANCES OF THE CITY OF MANILA RELATIVE TO THE FEES PAYABLE TO THE PHILIPPINE HEALTH SERVICE (NOW MANILA HEALTH DEPARTMENT), BY INCREASING THE FEES PROVIDED THEREIN.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Section 314 of the Compilation of Ordinances of the City of Manila is hereby amended to read as follows:

"SECTION 314. Fees payable to the Manila Health Department. - For the purpose of carrying out the provisions of this chapter, the following fees, payable to the Manila Health Department, shall be charged:

	<u>Actual Fees</u>	<u>Proposed Fees</u>
(a) For each burial permit issued..	P0.50	<u>P5.00</u>
(b) For each disinterment permit issued .....	P1.00	<u>P5.00</u>
(c) For the lease of each niche in any of the city cemeteries for a five-year period .....	P3.00	<u>P60.00</u>
(d) For the extension of the lease of each niche to one year or fraction thereof .....	P3.20	<u>P15.00</u>
(e) For each transcript of record of five years or less or for the reconstitution of a lost title to a lot or grave based on the records of the city cemeteries. ....	P1.00	<u>P5.00</u>
(f) For each transcript of record of more than five years or for the reconstitution of a lost title to a lot or grave based on the records of the city cemeteries.....	P2.00	<u>P10.00</u>
(g) For each permit to transport a body into or out of the City of Manila .....	P1.00	<u>P10.00</u>

PROVIDED, That no fee shall be charged for said permit in case deceased was at the time of death in the employ, or dependent for support upon a person in the employ of the Philippine Government: AND PROVIDED, FURTHER, That nothing in this chapter shall be construed as interfering with the right of the Manila Health Department of issuing gratis, burial permits for burial or other disposition of the remains of paupers; or of issuing gratis, transcripts of such records as may be required by the courts or by officers of the government for official purposes or to persons unable to pay for the same."

SEC. 2. This ordinance shall take effect upon its approval.
