

AN ORDINANCE AUTHORIZING HIS HONOR, THE MAYOR TO ENTER INTO A CONTRACT WITH A REPUTABLE CORPORATION, TO BE DETERMINED THRU PUBLIC BIDDING, FOR THE OPERATION AND MANAGEMENT OF THE PARKING LOT AT THE SUNKEN GARDENS ALONG TAFT AVENUE, INCLUDING THE USE OR DEVELOPMENT OF THE AREAS SURROUNDING THE SAID PARKING LOT, FOR A PERIOD OF TWENTY-FIVE (25) YEARS, UNDER CERTAIN CONDITIONS; AND FOR OTHER PURPOSES.

Be it ordained by the Municipal Board of Manila, that:

SECTION 1. Subject to the limitations of the City as administrator, and to Presidential Proclamation No. 314, series of 1952 and Presidential Proclamation No. 184, series of 1955, His Honor, the Mayor is hereby authorized to enter into a contract with any reputable corporation, to be determined thru public bidding, for the operation or management of the parking lot at the Sunken Gardens along Taft Avenue, including the use and development of the areas surrounding the same, for a period of twenty-five (25) years: PROVIDED, HOWEVER, That the City Mayor will impose terms and conditions which are most beneficial to the City of Manila.

SEC. 2. Pending implementation of this ordinance and the formal turn-over of the operation and management of the parking lot to the private contractor, Ord. No. 6536 shall remain in full force and effect and the City shall continue to collect the fees provided under Ord. 7302, as amended by Ord. 7330.

SEC. 3. Ordinance No. 6536, Ord. No. 7302 and Ord. No. 7330, all having relation to the parking lot at the Sunken Gardens are hereby repealed, subject to Section 2 hereof: PROVIDED, HOWEVER, That His Honor, the Mayor be authorized to settle the obligations of the City incurred in the construction of the parking lot at the Sunken Gardens.

SEC. 4. This ordinance shall take effect upon its approval.

Originally enacted by the Municipal Board of Manila on June 7, 1973; vetoed by His Honor, the Mayor on July 3, 1973 and repassed with amendments on July 31, 1973.
