

AN ORDINANCE CREATING A "MANILA BARANGAY BUREAU" AND APPROPRIATING AN AMOUNT THEREFOR FROM DECEMBER 1, 1973 TO JUNE 30, 1974.

It ordained by the Municipal Board of the City of Manila, that:

SECTION 1. A "Manila Barangay Bureau" is hereby created.

SEC. 2. The amount of P475,063.35, or so much thereof as may be necessary, is hereby appropriated out of the general and/or unappropriated funds of the City of Manila to be made available for the salaries and wages as well as other expenditures of the "Manila Barangay Bureau" as created in the preceding section covering the period from December 1, 1973 to June 30, 1974, as follows:
