

AN ORDINANCE APPROPRIATING THE SUM OF THREE MILLION EIGHT HUNDRED FORTY SEVEN THOUSAND, ONE HUNDRED THIRTY-SEVEN PESOS AND THIRTY-EIGHT CENTAVOS (P3,847,137.38) TO BE MADE AVAILABLE AS ADDITIONAL APPROPRIATIONS IN THE CURRENTLY ENFORCED APPROPRIATION ORDINANCE NO. 7393; AND FOR OTHER RELATED PURPOSES.

Be it ordained by the Municipal Board of the City of
Manila, that:

SECTION 1. The sum of THREE MILLION EIGHT HUNDRED FORTY SEVEN THOUSAND, ONE HUNDRED THIRTY-SEVEN PESOS AND THIRTY-EIGHT CENTAVOS (P3,847,137.38) or so much thereof as may be necessary, is hereby appropriated out of any available income of the City of Manila, not otherwise appropriated, to be made available for the following salary adjustments and other expenditures of the various departments and offices of Manila, as follows:
