AN ORDINANCE AMENDING ORDINANCE NO. 7520 BY INCREASING THE AMOUNT OF FEES AND CHARGES PRESCRIBED THEREIN.

Be it ordained by the Municipal Board of the City of Manila, that

SECTION 1. Ordinance No. 7520 is hereby amended to read as follows;

"AN ORDINANCE PRESCRIBING FEES AND OTHER CHARGES FOR THE SLAUGHTERING AND CORALLING OF ANIMALS IN THE CITY OF MANILA; PROVIDING PENALTY FOR VIOLATION THEREOF; AND FOR OTHER PURPOSE.

Be it ordained by the Municipal Board of the City of Manila, that;

"SECTION 1. Permit fee. Before any animal is slaughtered for public consumption, a permit therefor shall be secured from the City Health Officer concerned or his duly authorized representative thru the City Treasurer and the corresponding fee collected shall be as follows:

- (a) For each head of cattle, carabao, horse, buffalo, mule and other allied animals ... P1.00
- (b) For each head of pig, goat, sheep, deer, goose, turkey and others50
- (c) For each head of chicken, pigeon, quail, squab and other birds10

PROVIDED, HOWEVER, That game birds shall be exempted from the payment of this section.

"Sec. 2. Slaughter fee. There shall be charged and collected by the City Treasurer the following fees for the slaughter of the following in the City of Manila, which may either be per head or per kilo of dressed meat, whichever rate the Veterinary Inspection Board may choose to impose for the benefit of the City of Manila, depending on the prevailing circumstances. In case the fees to be charged would be per kilo, it would include liver, tongue, heart and other edible parts utilized for human consumption.

A. - On the basis of per head for public consumption:

Large cattle, per head	P7.50
Hogs	" "	4.50
Goats	" "	3.00
Sheep	" "	3.00
Other allied animals	3.00

B. - On the basis of per kilo for public consumption:

Large cattle, per kilo of dressed meat	..	0.075
Hogs	" " " " " "	0.045
Goats	" " " " " "	0.03
Sheep	" " " " " "	0.03
Other allied animals	" " " "	0.03
Chickens, turkey and other birds		
except game birds	0.03

C. - For home consumption on the basis of head:

Large cattle, per head	3.75
Hogs " "	<u>2.25</u>
Goats " "	1.50
Sheep " "	<u>1.50</u>
Others " "	<u>1.50</u>

D. - For home consumption on the basis of kilo:

Large cattle, per kilo	0.0375
Hogs " "	<u>0.0225</u>
Goats " "	0.015
Sheep " "	<u>0.015</u>
Others " "	<u>0.015</u>

"SEC. 3. There shall be charged and collected the following fees by the City Treasurer for meat stored in the different chilling rooms of the city abattoir at Vitas, Tondo, for each day or fraction thereof:

For each quarter size of dressed large animal or each entrail of large cattle (carabao, cattle, horse, buffalo, etc.)	<u>0.45</u>
For each carcass or entrail of small animals (pig, sheep, goat, etc.)	<u>0.35</u>
For each head of chicken, goose, pigeon, squab and duck	<u>0.015</u>
For each head of chicken, squab, quail or game bird	<u>0.0075</u>
For each head of turkey	0.05
For each kilo of fat, scrap meat or boneless meat, etc.	0.01

PROVIDED, HOWEVER, That for every imported frozen meat and meat food products, foreign meat, chilled meat and locally manufactured meat food products such as sausages, frankfurters, bologna, ham, bacon and similar products coming from sources outside the City of Manila and sold, open for sale and stored or otherwise found in the channels of trade in Manila shall be charged and collected a service fee of P0.05 per kilo.

"SEC. 4. The slaughter of any kind of animal for sale, or for consumption of the public, shall be done only in the city abattoir at Vitas, Tondo. The slaughter of animals intended for home consumption may be done elsewhere except large cattle.

PROVIDED, HOWEVER, That such animals slaughtered shall not be sold or offered for sale.

"SEC. 5. Upon the issuance of the permit required under Section 2 hereof, large cattle shall be slaughtered at the city abattoir at Vitas, Tondo. Before the issuance of the permit for the slaughter of large cattle, the City Treasurer shall require for branded cattle the production of the certificate of ownership if the owner is the applicant, or the original certificate of ownership and the certificate of transfer showing title in the name of the person applying for the permit if he is not the ori

SEC. 6. The following fees, per day or fraction thereof shall be collected for the animals to be slaughtered which are deposited and kept in the corral at the city abattoir at Vitas, Tondo:

Large cattle, per head	0.75
Hogs per head	0.45
Goats per head	0.30
Sheep " "	0.30
Others " "	0.30

"SEC. 7. Any person violating the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not less than P200.00 nor more than P500.00, or by imprisonment for not less than 15 days nor more than 2 months, or both such fine and imprisonment at the discretion of the court. In case of juridical persons, the president or person in charge of the operation thereof shall be liable for the violation hereunder."

SECTION 2. This ordinance shall take effect on July 1, 1974.
