

ORDINANCE NO. 7556

AN ORDINANCE AMENDING ORDINANCES NO. 7516, 7519, 7521 AND 7401

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Sec. 1 of Ordinance No. 7516, as amended by Ordinances No. 7544 and 7545 is further amended as follows:

1. The second sentence of the first proviso of Sub-section C-1 is amended by inserting the following, immediately after words "capital investment":

"but in no case shall it be less than the minimum provided therefor by the pertinent schedule."

2. The words "or fraction thereof" are hereby inserted immediately before the words "in excess of" in all the tax rate provisions of Sub-sections A, A-1, A-2, C, E, K and U.

3. The following is included under Sub-section J - "Lumberyards":

"500 square meters or less ..... P300.00

4. The tax rate for Private Detective or Security Agency under Sub-section T is increased from P50.00 to P75.00.

5. The tax rate for Golf Links under Sub-section W is increased from P1,000.00 to P1,500.00.

SECTION 2. The following provisions are inserted under Sec. 1 before Sec. 2 of Ordinance No. 7519:

"In cases where no sales and/or receipts are realized from operation of the business of printing and/or publication, the tax rate shall be the initial fee imposed for the pertinent business provided hereinabove".

SECTION 3. Sec. 3 of Ordinance No. 7401 is amended, to wit:

"Sec. 3. Payment and penalties - The taxes herein imposed shall be due and payable within the first twenty (20) days of the month next following that for which they are due, by THE proprietor, lessee, or operator concerned, such taxes to be determined on the basis of true and complete return of the gross receipts derived from the preceding month. Such returns must show the number of tickets sold, its serial numbers and the number of tickets remaining unsold at the end of the month. x x x "

SECTION 4. The fee for registration of divorce under Section 1 letter (a) 2, Art. XXI, is increased from P17.50 to P22.50.

SECTION 5. This ordinance shall take effect upon its approval.
