

ORDINANCE APPROPRIATING P875,898.00 FOR THE PURCHASE OF CERTAIN RESIDENTIAL LOTS FROM AGUS DEVELOPMENT CORPORATION TO BE RESOLD TO THE BONA FIDE TENANTS THEREOF.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P875,898.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury and/or from the funds appropriated under the currently enforced budget for the purchase of landed estates to be resold at cost in accordance with Ordinance 4709 for the purchase of the following residential lots from Agus Development Corporation to be resold to the bona fide tenants mentioned hereunder:




