

ORDINANCE NO. *7661*

AN ORDINANCE AUTHORIZING THE RESTORATION OF THE SALARY RATES OF CERTAIN POSITION-ITEMS IN THE DIFFERENT DEPARTMENTS OF THE CITY OF MANILA THAT WERE INADVERTENTLY REDUCED UNDER THE NEWLY-APPROVED BUDGET ORDINANCE NO. 7637, EFFECTIVE AS OF JULY 1, 1975, AND APPROPRIATING THE AMOUNT OF P3,040.00 NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The restoration of the salary rates of the following position-items in the different departments of the City of Manila that were inadvertently reduced under the newly-approved Budget Ordinance No. 7637, effective as of July 1, 1975, is hereby authorized, to read as follows:
