

AN ORDINANCE APPROPRIATING ₱1,000,000.00 FOR THE OPERATION TO BE CALLED "KALINISAN '75" TO IMPROVE THE CLEANLINESS OF THE CITY OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that;

SECTION 1. The amount of ₱1,000,000.00, or so much thereof as may be necessary, is hereby appropriated from the balance of the fund provided under Ord. No. 7491 for the operation to be called "Kalinisan '75" to improve the cleanliness of the City of Manila.

SEC. 2. In order to improve and maintain the cleanliness of the city, thru, a consistent campaign and active competition among the Barangays and Zones, cash awards, as incentives, shall be given to the following, the same to be utilized by them for the improvement of their respective Barangay and/or Zones:

A. For the cleanest Barangay in a congressional district per calendar quarter:

1st Prize - - - - -	₱5,000.00
2nd Prize - - - - -	4,000.00
3rd Prize - - - - -	3,000.00

For the cleanest Barangay in the city for the quarter (to be chosen from the four (4) district winners), an additional prize of ₱5,000.00.

B. For the cleanest Zone in a congressional district per calendar quarter:

1st Prize - - - - -	₱10,000.00
2nd Prize - - - - -	8,000.00
3rd Prize - - - - -	6,000.00

For the cleanest Zone in the City for the quarter, an additional prize of ₱10,000.00.

C. For the cleanest Barangays in the District for the year 1975:

1st Prize - - - - -	₱10,000.00
2nd Prize - - - - -	8,000.00
3rd Prize - - - - -	6,000.00

For the cleanest Barangay in the city for the year 1975, and additional prize of ₱10,000.00.

D. For the cleanest Zones in the District for the year 1975:

1st Prize - - - - -	₱20,000.00
2nd Prize - - - - -	16,000.00
3rd Prize - - - - -	12,000.00

For the cleanest Zone in the city ofr the year 1975, an additional prize of P20,000.00.

SEC. 3. Plaques will be awarded to all the winners with the corresponding description of the award given. Honorable Mentions for cleanliness on the Barangay and Zone levels may also be awarded with plaques.

SEC. 4. The Board of Judges, whose members shall be appointed by the Mayor, shall promulgate the rules and regulations of the aforementioned contest and shall also declare the winners thereof.

SEC. 5. This ordinance shall take effect upon its approval.
