WHEREAS, the SAMAHAN NG MGA MANGGAGAWA NG TUNDO, with office address at 1476 Quirino Street, Herbosa, Tondo, Manila, a duly registered organization with the Department of Labor and Employment (DOLE), is seeking accreditation as registered Non-Governmental Organization (NGO);

WHEREAS, SAMAHAN NG MGA MANGGAGAWA NG TUNDO, aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes which are stated in Tagalog are as follows:

1. Makipag-ugnayan sa alin mang ahensiya ng pamahalaan hinggil sa pagpapatupad ng mga programang pangkabuhayan, pangkapaligiran, pangkalinisan at pangkalusugan, tungo sa pagpapaunlad ng tahanan ng mga kasapi; at

Makagawa ng mga project proposals at maisakatuparan ng maayos at sa tamang paraan ng pagmumulat sa pamamagitan ng mga seminars at pagsasanay sa pakikipag ugnayan sa mga ahensiya ng pamahalaan, upang makatulong sa dagdag na kita ng mga kasapi o dagdag kaalaman para patatagin ang pundasyon ng bawat kasapi ng samahan.

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it


