WHEREAS, Senior Superintendent Christine Doctor-Cula was the first Fire District Marshal in the City of Manila, and has been a civil servant for the past 24 years;

WHEREAS, a District Fire Marshal is a government official who is responsible for the fire safety in an area, and who may also be a firefighter or police officer;

WHEREAS, the Department of Social Welfare and Development (DSWD) Field Office - National Capital Region is joining forces with the Bureau of Fire Protection (BFP) for the dissemination of advocacy regarding Fire Prevention Month with this year's theme: "Sa Pag-iwas sa Sunog, Hindi ka Nag-iisa!";

WHEREAS, the vision and mission of Bureau of Fire Protection (BFP) is a modern fire service fully capable of ensuring a fire safety nation by 2034 and commit to prevent and suppress destructive fires, investigate its cause; enforce Fire Code and other related laws; respond to man-made and natural disaster and other emergencies;

WHEREAS, fire incidents are potentially deadly and extremely dangerous, but by following precautionary measures from the authorities we can prevent unexpected fires and incidents;


