WHEREAS, for being a premier city and the capital of our country, many local government units expressed their desire to collaborate with the City of Manila through sisterhood relationship to enhance their capabilities, adopt our city's urban development plans and strategies, environmental protection and public health, arts and cultures, tourism, trade and industry and other fields of interests;

WHEREAS, the City of Manila has a time-honored policy of promoting friendly and cooperative relations with the local government units in the country and in other countries, as well, through twinning or sisterhood relationship to establish mutually beneficial development initiatives;

WHEREAS, on 04 August 2022, the Honorable Municipal Mayor of Lobo, Province of Batangas, together with the other officials of the said municipality, personally paid a visit to the City Government of Manila and expressed their people's desire for sisterhood scheme as encouraged by the Local Government Code of 1991 for the purpose of exchanging plans and programs and delivery of good public service towards the welfare and benefits of their constituents;

WHEREAS, the Municipality of Lobo is a 3<sup>rd</sup> class municipality in the province of Batangas, Philippines. According to the 2020 census, it has a population of forty thousand seven hundred thirty-six (40,736) and aims to improve the quality of life through their Mission for Progress and Good Governance Program;

WHEREAS, the City of Manila appreciates the intention of the people of the Municipality of Lobo, Batangas through their Chief Executive and the collaboration between the two (2) local government units will promote mutual benefits, cooperation and growth: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to establish, as it hereby establishes a Twinning City-Municipal alliance between the City of Manila and the Municipality of Lobo, Province of Batangas; and be it FURTHER

RESOLVED, that copies of this Resolution be furnished the Office of the Municipal Mayor, Hon. Lota L. Manalo and the Sangguniang Bayan of Lobo, Province of Batangas.
