WHEREAS, the City of Manila, under the leadership of Hon. Maria Sheilah “Honey” H. Lacuna-Pangan, MD, FPDS, aims to establish partnerships with other local government units in the Philippines to foster cooperation and collaboration for mutual benefit and progress;

WHEREAS, the Municipality of Famy, Province of Laguna, through Mayor Lorenzo B. Rellosa, has expressed its interest in establishing a twinning agreement with the City of Manila to enhance economic, cultural, educational, and social ties between the two LGUs last March 27, 2023;

WHEREAS, the proposed twinning agreement includes provisions for the exchange of best practices, experiences, and expertise in various fields such as tourism and cultural heritage, investment promotion, disaster risk reduction and solid waste management, education, health, and environmental protection;

WHEREAS, the proposed twinning agreement also includes provisions for the conduct of joint activities and projects, such as cultural and sports events, trade fairs, medical missions, and capacity-building programs, to promote people-to-people exchanges and learning opportunities;

WHEREAS, the proposed twinning agreement is deemed to be beneficial to the Municipality of Famy and City of Manila, as it will foster a stronger relationship between the two LGUs, promote mutual understanding and respect, and contribute to their respective development goals: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the establishment of a twinning agreement between the City of Manila and the Municipality of Famy, Province of Laguna; and be it FURTHER


