WHEREAS, in the recently held 3rd Philippine SK Awards, Sangguniang Kabataan Chairperson, John Daniel Martinez Layno of Barangay 857, Zone 93, City of Manila, won the Most Outstanding SK Environmental Project in the Philippines for his project entry, entitled: "PLANTHORIA, AN EDIBLE COMMUNITY BARANGAY EMPOWERMENT THROUGH ENVIRONMENTAL CONSERVATION PRACTICES";

Layno, born to parents Johanna and Joel Layno from District VI in the City of Manila, a 27 year-old graduate of Bachelor of Science Major in Travel and Tourism, has been awarded as Manila Youth Bureau 2020's, Most Outstanding Sangguniang Kabataan Chairperson of Manila, Lyceum of the Philippines Student Leadership Award 2019, Roberto P. Laurel Presidential Award Gold Medalist 2016, 2017, 2018 and 2019;

WHEREAS, SK Chairperson JD, as fondly called, started serving the community since 2010 as Sangguniang Kabataan Kagawad and a run for the 2018 Barangay elections and seated as the Sangguniang Kabataan Chairperson of the Barangay 857, Zone 93 Council;
