WHEREAS, it is the desire and interest of the people of Silay City with a population of one-hundred thirty thousand four hundred seventy-eight (130,478) inhabitants to have a Twinning Relationship with the City of Manila in order to have a mutually beneficial endeavor between the two (2) cities and also to develop and encourage greater friendly relationship and better understanding between the people of the two (2) cities thru the exchange of the following:

- a. Culture
- b. Education
- c. Studies in commercial, industrial and agricultural fields
- d. Information covering areas of government administration, community development, basic and infrastructure services to the residents;

NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila authorize, as it hereby authorizes the establishment of a Twinning Relationship between the City of Manila and the City of Silay, Negros Occidental; and be it FURTHER

RESOLVED, that the City Mayor of Manila, Honorable Maria Sheilah "Honey" Lacuna-Pangan, MD, FPDS, be authorized to execute and sign said agreement; and be it FINALLY
