WHEREAS, the PEOPLE'S VOLUNTEER AGAINST ILLEGAL DRUGS INC., with office address at 4/F Padavela Bldg. 2011 G. Tuazon St. corner Samar St., Sampaloc, Manila, a duly registered organization with the Securities and Exchange Commission (SEC) is seeking accreditation as registered Non-Governmental Organization;

WHEREAS, PEOPLE'S VOLUNTEER AGAINST ILLEGAL DRUGS INC., aims to contribute to uplift and develop the quality of life, not only the members, but also to the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

1. To promote a vigorous campaign against illegal drugs in order to protect the well-being and welfare of the Filipino family as productive and responsive citizen of our society;
2. To enter into bilateral relations with the different government line agencies, non-government organizations, and other groups or associations charged with or interested in the promotion and implementation of the Comprehensive Dangerous Drugs Act of 2002, including private entity that support the campaign drive against drug abuse;
3. To engage in the conduct of public symposia or other activities which can serve as a vehicle and tool of promoting the Drug Abuse Resistance Education program of the organization in every community, schools, parents and teachers organization and private sectors, as an essential contribution to nation building;
4. To promote and approve the execution of future related civic projects in support of the organization;
5. To solicit, receive, manage, or raise funds for the civic projects calculated to combat the use of illegal drugs or to rehabilitate the victims of illegal drugs; and
6. To grant certifications and other recognitions to different government line agencies, non-government organizations, and other groups or associations which are proven to be an excellent public servant that combats the use and the harmful effects of drug abuse.

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it


