WHEREAS, this Resolution is in pursuance with the Department of the Interior and Local Government (DILG) Memorandum Circular No. 97-306 dated November 25, 1997, in establishing and maintaining friendly ties, peace and unity and to participate in significant activities geared towards the enhancement and to enliven the cultural, economic and livelihood programs, mutually beneficial among local government units;

WHEREAS, this is also envisioned to achieve national progress, economic growth among the different local government units through sharing of technical know-how and common objectives on significant programs, projects and activities;

WHEREAS, the Municipality of Allacapan, Province of Cagayan, furnished Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, a certified copy of their Municipal Resolution No. 2022-11-212 dated October 10, 2022, duly passed by its Sangguniang Bayan and approved by their Municipal Mayor, Honorable Harry D. Florida, embodying a resolution requesting the City of Manila to have a Twinning Agreement with the Municipality of Allacapan, Province of Cagayan;

WHEREAS, this Resolution is intended to deepen the economic, tourist and cultural aspects of the municipality through continuous learning and collaboration with other agencies with common dreams and interests that could help in the achievement of such objective by means of twinning;


WHEREAS, in behalf of the people of Allacapan, Cagayan, led by their Honorable Mayor Harry D. Florida and duly concurred by the Honorable Members of the Sanggunian of the said municipality, it is noteworthy to express their desire to have a twinning agreement with the City of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to authorize, as it hereby authorizes the establishment of a Twinning Relationship between the City of Manila and the Municipality of Allacapan, Province of Cagayan; and be it FURTHER

RESOLVED, that the City Mayor of Manila, Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS, be authorized to execute and sign said agreement; and be it FURTHERMORE


RESOLVED, that a copy of this Resolution be furnished the Municipality of Allacapan, Province of Cagayan.
