WHEREAS, the BOHOL BLUMENTRIT MINDANAO TODA INC., with office address at 1043 Bohol Street corner G. Tuazon Street, Sampaloc, Manila, a duly registered organization with the Securities and Exchange Commission (SEC) is seeking accreditation as registered People's Organization (PO);

WHEREAS, BOHOL BLUMENTRIT MINDANAO TODA INC., aims to contribute to uplift and develop the quality of life, not only the members, but also to the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

1. To organize an association of tricycle operators & drivers plying the route from Bohol St., Blumentrit, and Mindanao Avenue and vice-versa;
2. To develop cooperation, assistance, harmony and understanding among the members to advance their economic and social status, as well as spiritual and moral well-being;
3. To cooperate closely with the government in view of carrying out all the aims and goals of our society;
4. To consult from time to time the government or its agencies to promote and carry out effectively all programs of the government;
5. To assist and coordinate with appropriate government agencies in the implementation of transportation law and traffic rules and regulations;
6. To enlighten all the members through seminars and training in regard to their rights and obligation, and other matters regarding the convenience and safety of the riding public;
7. To do perform all other acts and deeds as may be necessary, convenient and appropriate for the accomplishment of the foregoing purpose.

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;


