WHEREAS, the first Manila Inter-Zone Basketball Tournament is the first ever City-Wide basketball league program headed by the City Mayor, Honorable Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS and Vice-Mayor, Honorable John Marvin C. "Yul Servo" Nieto, mainly focusing on the youth of the City of Manila, giving them an opportunity to develop their skills in basketball, and at the same time, discourage them from falling into the bad habits of consuming alcohol and drugs;

WHEREAS, eighty-three (83) different basketball teams representing the different districts and zones of the City of Manila participated in the First Manila Inter-Zone Basketball Tournament for Men which took place from 10 October 2022 to 23 October 2022;

WHEREAS, in the District-Level Championship game, Zone 12 of District 1, Zone 16 of District 2, Zone 27 of District 3, Zone 47 of District 4, Zone 80 of District 5, and Zone 93 of District VI, emerged victorious over the other zones that competed in the districts;

WHEREAS, in the Battle of the Champions which took place on 23 October 2022, a game which is a phenomenal event in itself, showing both teams' talent and expertise and the overwhelming support from the crowd, District V, Zone 80, team displayed remarkable basketball prowess and skills and won as the Champion of the First Manila Inter-Zone Basketball Tournament over the team District VI, Zone 93, last Sunday, 23 October 2022;

WHEREAS, District VI, Zone 93 team, the tournament's 1st runner-up, also showed exceptional skills during the basketball tournament, as well as District I, Zone 12 team, the tournament's 2nd runner-up;

WHEREAS, the program includes the following cash prizes; for the City Champion: One Hundred Thousand Pesos (PhP. 100,000.00), for the First Runner-Up: Fifty Thousand Pesos (PhP. 50,000.00), for the Second Runner-Up: Thirty Thousand Pesos (PhP. 30,000.00), for the Most Valuable Player: Five Thousand Pesos (PhP. 5,000.00), for the District Champion: Twenty Thousand Pesos (PhP. 20,000.00), and lastly, for the Mythical Five: Two Thousand Pesos (PhP. 2,000.00) for each player;

WHEREAS, District V, Zone 80, District VI, Zone 93, and District I, Zone 12, achieved the outstanding accomplishments despite the great odds and difficulties which came their way during their preparations for the basketball tournament;

WHEREAS, the team's triumph is the triumph of all the youth of the city, proving that with the support of the City of Manila, no amount of obstacles and disparagement will ever dampen the youth's spirit and that Manileños will continue to excel in different competitions despite the odds;

WHEREAS, it is also necessary that this Council honor and commend, Honorable Mayor Maria Sheilah "Honey" H. Lacuna-Pangan, MD, FPDS and Honorable Vice-Mayor John Marvin C. "Yul Servo" Nieto for the success of the First Manila Inter-Zone Basketball Tournament, the first ever City-Wide Basketball League initiated by the City of Manila;


