WHEREAS, UNITED TENANTS AND ROOM RENTERS ASSOCIATION OF MANILA INC., aims to contribute to uplift and develop the quality of life, not only the members, but also to the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the NGO concerned.
