WHEREAS, on July 9, 1981, an eight-storey building was constructed and named as Manila Abuse Rehabilitation and Medical Center (MARMC);

WHEREAS, in 1987, the Manila Health Department begins its supervisory power over MARMC and named it as Sampaloc Community Reference Infirmary (CRI);

WHEREAS, the City Council of Manila paved the way for the creation of Ospital ng Sampaloc (OSSAM) through Ordinance 7835, and finally inaugurated on October 13, 1998;

WHEREAS, OSSAM has since then gained prominence in medical service and was awarded several citations and accreditations such as PhilHealth provider institution, Center of Quality by the PhilHealth Corporation and as a Mother Baby Friendly Hospital and a Newborn Screening Facility;

WHEREAS, during Director Aileen A. Lacsamana's stint in office, OSSAM has finally won the coveted International Standardization for Organization (ISO) 9001-2015 Certification: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to commend, as it hereby commends the management and staff of Ospital ng Sampaloc (OSSAM) under the stewardship of Director Aileen A. Lacsamana, MD, FFPS, MPA, MHA, for its continuing dedication to excellence towards fulfillment of its mandate, vision and mission to the public; and be it FURTHER
