WHEREAS, the SAN MIGUEL MANILA URBAN POOR ASSOCIATION INC., with office address at 281-H Barcastegui Street, San Miguel, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered People's Organization (PO);

WHEREAS, SAN MIGUEL MANILA URBAN POOR ASSOCIATION INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

1. To establish an association that will promote a housing program;
2. To work with government agencies for availment of projects and programs that will help to alleviate the condition of members; and
3. To protect the security and interest of members.

RESOLVED, by the City Council of Manila to grant, as it hereby grants the renewal of accreditation of San Miguel Manila Urban Poor Association Inc., to become an accredited People's Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the PO concerned.
