RESOLUTION GRANTING THE RENEWAL FOR ACCREDITATION OF LA PROTECCION DE LA INFANCIA, INC., TO BECOME AN ACCREDITED NON-GOVERNMENTAL ORGANIZATION OF THE CITY OF MANILA

WHEREAS, the LA PROTECCION DE LA INFANCIA, INC., with office address at 859 S. H. Loyola Street, Sampaloc, Manila, a duly registered organization with the Department of Social Welfare and Development (DSWD), is seeking accreditation as registered Non-Governmental Organization (NGO);

WHEREAS, LA PROTECCION DE LA INFANCIA, INC., aims to contribute in the upliftment and development of the quality of life, not only of the members, but also of the less fortunate members of the society, as well as launching various humanitarian and livelihood programs that are designed to promote self-reliance and economic independence;

WHEREAS, the Association's purposes are as follows:

1. To protect and preserve the health of the children and infants from birth to fifteen years of age, by the establishment of child and feeding centers, and children's health facilities;
2. To provide milk, medical and nutritional counselling, as well as occasional medical and nutritional supplements for malnourished children;
3. To disseminate information for the proper care and physical development of children and infants;
4. To help prevent the spread of children's disease and ailments, and to afford relief to those afflicted through every known scientific means;
5. To ensure the health and development of girl-children and young adolescents girls, through the promotion of integrated family health, puberty education and safe environments; and
6. To establish and sustain programs that focus on the health and welfare of women of productive age.

WHEREAS, the same organization submitted the accomplished requisites and supporting documents for purposes of accreditation;

WHEREAS, after careful study and perusal of all the requirements submitted, it was established that it has all the qualifications to be accredited as a Non-Governmental Organization of Manila: NOW, THEREFORE, be it

RESOLVED, by the City Council of Manila to grant, as it hereby grants the renewal of accreditation of La Proteccion De La Infancia, Inc., to become an accredited Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the NGO concerned.
