WHEREAS, the BARANGAY LABAN SA INHUSTISYA KORAPSYON ABUSO TERORISMO AT NARKOTIKO (BALIKATAN) INC., with office address at 601 – A. Gen. Geronimo Street, Sampaloc, Manila, a duly registered organization with the Securities and Exchange Commission (SEC), is seeking accreditation as registered Non-Governmental Organization (NGO);

RESOLVED, by the City Council of Manila to grant, as it hereby grants the accreditation of Barangay Laban sa Inhustisya Korapsyon Abuso Terorismo at Narkotiko (BALIKATAN) Inc., to become an accredited Non-Governmental Organization of the City of Manila; and be it FURTHER

RESOLVED, that a corresponding Certificate of Accreditation be attached hereto and be issued to the said association; and be it FINALLY

RESOLVED, that copies of this Resolution be furnished the Department of the Interior and Local Government (DILG) and the NGO concerned.
