

AN ORDINANCE APPROPRIATING THE SUM OF ₱200,000.00 TO BE MADE AVAILABLE FOR THE UNDERTAKING OF PUBLIC IMPROVEMENTS IN THE DIFFERENT PARTS OF THE CITY OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The sum of ₱200,000.00, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated, to be made available for the undertaking of the following public improvements in the different parts of the City of Manila, to wit:

1. For the asphaltting of Pingkian Street from Arqueros southward, Tondo ₱ 17,700.00
2. For the asphaltting of Tayabas Street from Almeda up to the railroad tracks, Tondo 19,500.00
3. For the raising of Quesada Street from Moriones to Pavia Streets, Tondo 5,800.00
4. For the construction of concrete curbs and gutters on both sides of Asuncion Street from Azcarraga to Lakandula Streets, Tondo 7,000.00
5. For the asphaltting of Oroquieta Street from Blumentritt to Tecson Streets including curbs and gutters 18,000.00
6. For the asphaltting of Loaisa Street from David Street to Estero de la Reina 3,000.00
7. For the asphaltting of Kalimbas Street from Requesens to one block, including curbs and gutters 6,000.00
8. For the asphaltting of J. de Moriones Street, San Nicolas 2,000.00
9. For the asphaltting of M. Natividad Street from Mayhaligue northward, including storm drainage and gutters 7,000.00
10. For the asphaltting of Andalucia Street from Gov. Forbes to San Lazaro 15,000.00
11. For the asphaltting of P. Guevara Street from Isabel Street to the estero 8,600.00
12. For the asphaltting of Kundiman Street between Maria Clara and Laong-Laan Streets, Sampaloc 6,400.00
13. For the construction of Florentino Street from Blumentritt to Callejon Tasio and improvement of Callejon Tasio 2,500.00
14. For the construction in Barrio Malamig of Basketball Court, basketball standard, installation of lights, six (6) bulbs and complete fencing 7,150.00
15. For the complete fencing of MPD Precinct No. 6, installation of six (6) bulbs light and construction of basketball standard 4,550.00
16. For the paving of Sobriedad Street Extension from Matimyas to Quezon Boundary .. 7,000.00
17. For the asphaltting of Basilio Street from España to P. Florentino Streets 7,500.00
18. For the filling of Paquita Street from España to Isabelo de los Reyes 2,000.00
19. For the asphaltting of Nebraska Street from Herran to Tennessee Streets 8,500.00
20. For the asphaltting of Zobel Street from San Marcelino to Marquez de Comillas Streets 10,000.00

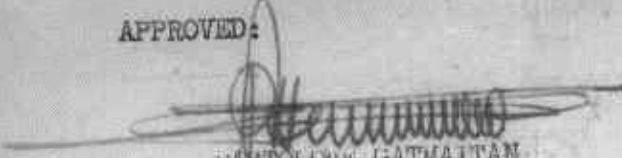
21. For the asphaltting of Kansas Street from California to Herran Streets	7,000.00
22. For the asphaltting of Amatista Street from San Andres to Dagonoy Streets, including the construction of curbs and gutters	22,500.00
23. For the improvement of the drainage of Lorenzo de la Paz Street from Beata to Isidro Certeza, Pandacan	5,300.00
Total	<u>200,000.00</u>

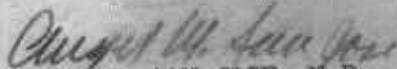
