

AN ORDINANCE IMPLEMENTING REPUBLIC ACT NO. 1201, CREATING ADDITIONAL POSITIONS IN THE MUNICIPAL COURT AND APPROPRIATING FUNDS NEEDED THEREFOR, INCLUDING THE PURCHASE OF FURNITURE FOR BRANCH VIII (TRAFFIC COURT).

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The sum of ₱22,499.75, or so much thereof as may be necessary, is hereby appropriated out of any funds (expected over-collection from amusement tax) existing in the City Treasury not otherwise appropriated, and is made available for the payment of the salaries of the eight (8) Judges of the Municipal Court of the City of Manila, as provided for in Republic Act No. 1201, as well as the purchase of furniture, as follows:

a. One Judge at ₱10,000.00 per annum from November, 1954 to June, 1955	₱ 6,666.64
b. One Judge at ₱10,000.00 per annum from December, 1954 to June, 1955	5,833.31
c. Differential in salary of six (6) Judges from ₱9,000.00 to ₱10,000.00 beginning September, 1954	4,999.80
d. For the purchase of furniture for Branch VIII (Traffic Court)	5,000.00
Total	<u>₱22,499.75</u>

SEC. 2. The following additional positions are hereby created in the Municipal Court under Branches VII and VIII with their designations and rates of compensation as shown herein, which are needed in said Municipal Court as a result of the increase of the number of Judges in the aforesaid Court under Republic Act No. 1201, and the sum of ₱46,295.00 is hereby appropriated out of any funds (expected over-collection from amusement tax) existing in the City Treasury not otherwise appropriated, and is made available for the payment of the salaries corresponding to the additional positions aforementioned, as follows:

a. One Deputy Clerk of Court at ₱2,760.00 per annum from November 15, 1954 to June, 1955	₱ 1,725.00
b. One Deputy Clerk of Court at ₱2,760.00 per annum from December, 1954 to June, 1955	1,610.00
c. One Clerk at ₱2,400.00 per annum from December, 1954 to June, 1955	1,400.00
d. Three Bailiffs at ₱2,400.00 per annum from December, 1954 to June, 1955	4,200.00
e. Three Janitors at ₱1,920.00 per annum from November 15, 1954 to June, 1955	3,600.00
f. Three Janitors at ₱1,920.00 per annum from December, 1954 to June, 1955	3,360.00
g. Six Laborers at ₱1,920.00 per annum from November 15, 1954 to June, 1955	7,200.00
h. Ten helpers at ₱1,920.00 per annum from November 15, 1954 to June, 1955	12,000.00
i. Ten helpers at ₱1,920.00 per annum from December, 1954 to June, 1955	11,200.00
Total	<u>₱46,295.00</u>

SEC. 3. This ordinance shall take effect as of November 1, 1954.

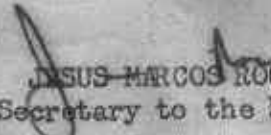

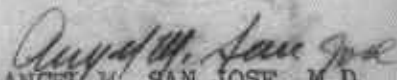
