

AN ORDINANCE AUTHORIZING THE ADJUSTMENT OF CERTAIN ITEMS IN THE CURRENT APPROPRIATION OF THE MANILA POLICE DEPARTMENT, ORDINANCE No. 3767; AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The adjustment of the following items in the current appropriation of the Manila Police Department, Ordinance No. 3767, is hereby authorized, so that said items shall read as follows:
