

AN ORDINANCE APPROPRIATING THE SUM OF P355,533.00 TO BE MADE AVAILABLE, AS ADVANCED APPROPRIATION, FOR THE OPERATION AND MAINTENANCE OF NEW INTERMEDIATE AND SECONDARY CLASSES FOR THE SCHOOL YEAR 1956-1957, UNDER THE DIVISION OF CITY SCHOOLS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The sum of P355,533.00, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated, to be made available, as advanced appropriation, for the operation and maintenance of new Intermediate and Secondary classes for the school year 1956-1957, under the Division of City Schools, itemized as follows:

A. INTERMEDIATE SCHOOLS

1. Salaries of fifty-two (52) clerks at P1,800.00 p.a.	P 93,600.00*
2. Salaries of thirty-two (32) nurses at P2,400.00 p.a.	76,800.00*
3. Wages of six (6) janitors at P1,680.00 p.a.	10,080.00*
4. Supplies and materials including water consumption	11,520.00*
5. Rentals of buildings and grounds (64 rooms at P70.00 per month per room) ..	44,800.00*
6. Illumination and power service	4,096.00*
7. Furniture and equipment	38,000.00*
8. Life and retirement insurance premium ..	12,922.00*

B. HIGH SCHOOLS

1. Wages of eleven (11) janitors at P1,680.00 p.a.	P 18,480.00*
2. Supplies and materials including water consumption	4,000.00*

4. Illumination and power service	1,400.00*
5. Furniture and equipment	23,142.00*
6. Life and retirement insurance premium ..	1,293.00*
