

AN ORDINANCE APPROPRIATING THE SUM OF ₱8,500.00 TO BE MADE AVAILABLE FOR THE CONSTRUCTION OF CATWALKS AND FILLING IN OF THE DIFFERENT STREETS AND CALLEJONES IN THE FOURTH DISTRICT OF THE CITY OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The sum of ₱8,500.00, or so much thereof as may be necessary, is hereby appropriated out of any funds (from the surplus realized by the City for the fiscal year 1956-1957) existing in the City Treasury not otherwise appropriated, to be made available for the construction of catwalks and filling in of the different streets and callejones in the Fourth District of the City of Manila, as follows:

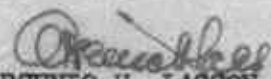
