

AN ORDINANCE ADJUSTING THE APPROPRIATIONS OF CERTAIN ITEMS IN THE DIFFERENT DEPARTMENTS AND OFFICES OF THE CITY GOVERNMENT UNDER ORDINANCE NO. 3864 WHICH WERE RESTORED BY VIRTUE OF THE VETO OF HIS HONOR, THE MAYOR OF THE ITEMS PERTAINING THERETO IN ORDINANCE NO. 3993, APPROPRIATING FUNDS NEEDED THEREFOR, AND FOR OTHER PURPOSES.
