

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱807,128.82 TO BE MADE AVAILABLE FOR THE MAINTENANCE AND OPERATION OF FORTY-EIGHT (48) ADDITIONAL FIRST YEAR CLASSES AND SEVENTY-FIVE (75) NEW INTERMEDIATE CLASSES FOR THE SCHOOL YEAR 1958-1959.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱807,128.82, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available for the maintenance and operation of forty-eight (48) additional first year classes and seventy-five (75) new intermediate classes for the school year 1958-1959, itemized as follows:
