

AN ORDINANCE AUTHORIZING THE CREATION OF CERTAIN POSITIONS AND ITEMS IN THE MANILA CITY LIBRARY, DIVISION OF CITY SCHOOLS, MANILA HEALTH DEPARTMENT AND THE MANILA POLICE DEPARTMENT; PROVIDING ADDITIONAL APPROPRIATIONS FOR CERTAIN ITEMS IN THE MANILA CITY LIBRARY AND THE DEPARTMENT OF PUBLIC SERVICES, UNDER ORDINANCE NO. 4021; APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:
