

AN ORDINANCE RESTORING AND/OR GRANTING GASOLINE OR AUTOMOBILE ALLOWANCES TO THE HEADS OF THE DIFFERENT DEPARTMENTS AND OFFICES OF THE CITY GOVERNMENT; AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Gasoline or automobile allowances of the heads of the following Departments and Offices of the City Government for the use of their privately-owned automobiles are hereby restored and/or granted, as follows:

1. DIVISION OF CITY SCHOOLS:

- a. Automobile allowance for the Superintendent of City Schools at P240.00 per month P2,880.00
- b. Automobile allowance of the Asst. Superintendent of City Schools at P160.00 per month 1,920.00
- c. Automobile allowance for the Asst. Superintendent for elementary education at P160.00 per month 1,920.00
- d. Automobile allowances for five (5) Supervisors at P40.00 per month 2,400.00 P 9,120.00

2. MANILA CITY LIBRARY:

- a. Gasoline allowance for the Superintendent at P50.00 per month P 600.00
- b. Gasoline allowance for the Chief Supervisor at P50.00 per month 600.00
- c. Gasoline allowance for the Administrative Officer at P50.00 per month ... 600.00 P 1,800.00

✓ 3. OFFICE OF THE CITY FISCAL:

- ✓ a. Gasoline allowance for the City Fiscal P 2,618.00
- b. Gasoline allowances for the First Asst. City Fiscal and three (3) Second Asst. City Fiscals at P120.00 per month each 5,760.00

- e. Gasoline allowances for three (3) Asst. Fiscals assigned to Night Court at P50.00 per month each 1,800.00 P20,378.00

a. Gasoline allowances of the Health Supervisors and Division Chiefs who make frequent inspections ₱2,000.00 ₱ 2,000.00

✓ 8. DEPARTMENT OF PUBLIC SERVICES:

a. Gasoline allowance of the City Public Service Officer at ₱240.00 per month ₱2,880.00
b. Gasoline allowance of the Asst. City Public Service Officer at ₱200.00 per month 2,400.00
c. Gasoline allowance of Chief, Division of Services at ₱70.00 per month 840.00 ₱ 6,120.00

9. OFFICE OF THE CITY AUDITOR:

a. Automobile allowance for the Asst. City Auditor at ₱160.00 per month .. ₱1,920.00
b. Automobile allowance for the Chief, Property Division at ₱100.00 per month 1,200.00
c. Automobile allowance for the Chief, Property Section at ₱80.00 per month. 960.00 ₱ 4,080.00

10. OFFICE OF THE MUNICIPAL BOARD:

a. Gasoline allowance for the Secretary, Municipal Board at ₱160.00 per month. ₱1,920.00 ₱ 1,920.00
GRAND TOTAL ----- ₱1,378.00

SEC. 2. The amount of ₱1,378.00, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available for the payment of the gasoline or automobile allowances mentioned in Section One hereof.

SEC. 3. This Ordinance shall take effect as of July 1, 1958.
