AN ORDINANCE AUTHORIZING THE ESTABLISHMENT OF A PUBLIC LIBRARY AT THE JUNCTION OF MANUGUIT EXTENSION AND RIZAL AVENUE; CREATING CERTAIN POSITIONS AND ITEMS THEREIN; AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The establishment of a public library at the junction of Manuguit Extension and Rizal Avenue is hereby authorized.

SEC. 2. The creation of the following positions and items for the public library mentioned in Section 1 hereof is likewise hereby authorized:
